ELECTION PROVISIONS AND SCHEDULE 2019 - 2021

1. Pursuant of relevant clauses of the Articles of Association of Bangladesh Professional Golfers' Association (BPGA), election of Governing body, Players participatory committee(PPC) and Bangladesh Lady Professionals Golf Association (BLPGA) will be held in2 (two) phases on 21 September 2018 (Friday) and 22 September 2018 (Saturday) at KGC, Dhaka Cantonment as follows:

1st phase: Election of 5 (five) Members each from PPC & BLPGA.

2nd phase: Election of 12(Twelve) Members Governing Body.

Following positions will be selected among the elected members of PPC:

- 1) The Player Captain
- 2) Vice captain -1
- 3) Vice Captain 2
- 4) Coordinator 1
- 5) Coordinator 2

Following position will be selected among elected members of BLPGA:

- 1) The Convener
- 2) Vice Convener
- 3) Secretary General
- 4) The Joint Secretary
- 5) Treasurer

Following position will be selected among elected members of Governing Body:

- 1) The President
- 2) Vice President (Finance & Welfare)
- 3) Vice President (General & Administration)
- 4) Secretary General
- 5) The Joint Secretary
- 6) Treasurer
- 7) Member Operation
- 8) Member Operation 2

- 9) Member Golf Development
- 10) Member (Sales & Marketing)
- 11) Member Tour Administration
- 12) Member Media & Publicity

The Captain and Vice Captain– 1 from PPC and Convener(President) as the case may be, from BLPGA will be ex-officio members of Governing Body.

2. Eligibility of Voters:

- (1) All the professional golfers, golf professionals' and all lady members in the category of PPC and BLPGA and generalmembers BPGA whose names appear in the current "Members Register" of BPGA at least 60days immediately preceding the election;
- (2) Who have cleared subscriptions prior to the date of election. This will be vetted by the election commission:
- (3) The suspended/debarred BPGA members are not eligible to participatein BPGA Election;

3. <u>Election of Governing Bodyfor Electing 12 members:</u>

Allgeneralmembers of BPGA and 5 elected members each from PPC & BLPGAshall elect 12 (Twelve) members of the Governing Body based on the highest number of votes received. The voting will be held on separate day as per election scheduleas stated subsequently.

4. <u>Election Commission and Election Appeal Committee (EAC).</u>

EAC will consist of 3 (three) members who are not members of the current Governing Body or seeking or signing nomination as proposer or seconder of the candidates seeking election in any of the above category.

5. Viewing Update on KGC Notice Board/Website.

8. Voters' list will be available at the BPGA office to interested members at a cost of Tk. **1,000.00 (One Thousand) only** per set during office hours.

9. For the convenience of the voters, 3R size color photographs of candidates appearing on the final list of contestants for the election will be displayed on a boardto be placed at BPGA office, together with their names appearing in alphabeticalorder as on the ballot paper.

 All matters connected with contesting in and conduct of elections shall be dealt with strictly following the provisions of the Memorandum of Association Election byelaws, 2018.

11. Other Instructions.

11.1. BPGA members are advised to carry their identity card and demanded by

the BPGA Election Commission to ascertain the identity during voting.

- 11.2. Election Commission reserves the right to cancel candidate's candidature for violation of election instructions or any relevant clause of Articles of Association of BPGA' pertaining to election. The cancellation will be communicated in writing to the candidate, copying Chairman Election Appeal Committee and current BPGA governing body.
- 11.3. Each candidate may nominate one BPGA member (having eligibility to vote) to act as his/her polling agent before conduct of election in writing to BPGA Election Commission who may:

(1) remain present at the polling center during vote casting and counting,

(2) sign tabulation and compiled result sheets of the election on completion of counting votes.
